[MCIX-1909] - Testing file uploading to check the data correctness

We added a new feature to be able to check the own data correctness before actual file uploading with the purpose to improve data quality and importing only the correct data to MCIX.

It is a testing checkbox and superusers can use this checkbox to test their own data correctness before uploading the actual data file.

The checkbox will be auto-selected when uploading the file on the upload page for the new MFI.

If the MFI made the same mistakes over and over again, we will identify the MFI as a repeated offender and the checkbox will be auto-selected for this MFI when uploading the file.

It is just pre-selected and superusers can do the unselect the checkbox if they believe that their data are correct and don't want to use the testing feature for the file.

The existing MFIs can also use this feature when the superusers or staff who are responsible for data preparation are recently joined the MFI and are not confident in their preparation. Or they can use it if they want to test the correctness of data.

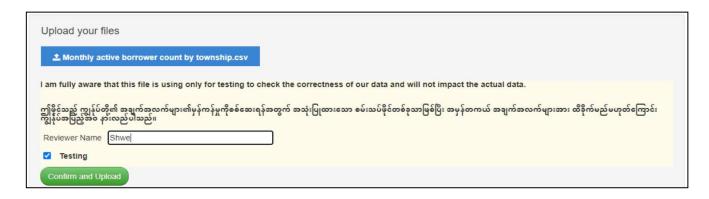
