[MCIX-1232] – Added ThitsaID request form and updated the template explanation on the upload page

ThitsaID request template is added on the upload page and should be used for requesting ThitsaIDs for people who do not have NRC. Users can download the sample ThitsaID request form template and upload the file once the information is filled out. Depending on the number of ThitsaID requests, the process can take from 1 day to a week. Once the IDs are generated, the file with ThitsaIDs will be made available in Processed Folder. Users can get to the Processed folder by clicking the view stats and download the generated ThitsaID file.

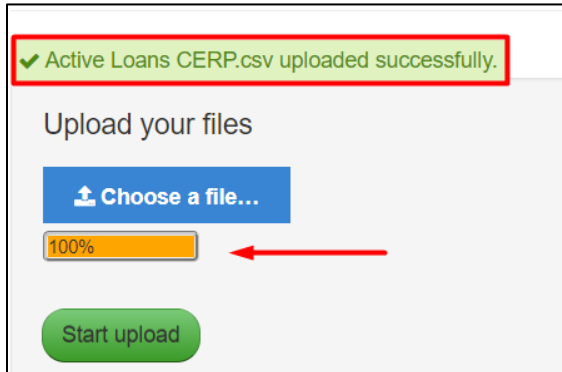

[MCIX-1037] – Increased the file size limitation from 10 MB to 150 MB for the upload process

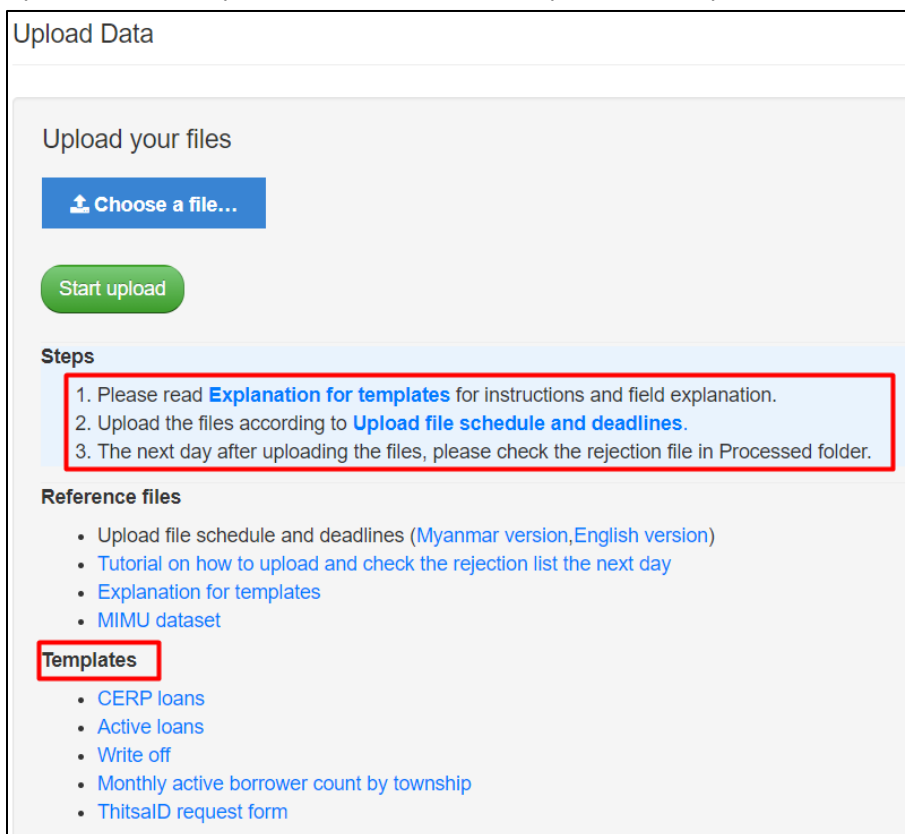
The limitation of upload file size is increased to 150 MB instead of 10 MB for the upload process.

[MCIX-1294] – Improved the Upload File screen

Upload screen is updated and referred to the provided template list in the Templates section.



[MCIX-1235] – Changed the template name and link of Active Loans CERP into CERP loans

Changed the template name from **Active Loans CERP** to **CERP Loans** because MFIs need to upload the latest repayment even if there is no outstanding amount for the CERP loan. Please use the new template and filename otherwise the file will not be processed.

Allowed the Total Principal Write-off amount with blank in "Monthly active borrower count by township". If users didn't want to share write-off data or didn't want to contribute write-off data, users can leave blank in the amount field.

[MCIX-270] – Added validation in file upload to ensure the content is Comma Separated Values or Semi colon

Add validation in file upload to ensure the content is Comma Separated Values or Semicolon.

[MCIX-1231] – Disable the status of loan and borrower when the outstanding amount is zero

Added a new feature to disable the status of last repayment borrowers and loans when the outstanding amount is zero. If the users imported the loans with zero outstanding amounts, the automatic process will disable the status of borrowers and loans.

[MCIX-1233] – Display ThitsaID in the Search result

The new column "ThitsaID" is added in both simple search and bulk search screens to able to see the ID of the people who have no NRC. Users can able to search the borrower by using the ThitsaID.

[MCIX-1302] – Limited the Bulk Search to maximum 100 records

A new feature is added to limit the maximum records to 100 to search in the bulk search per upload. As we know, we just suggested to search only 100 NRCs per upload, but some users searched over 100 records. To reduce huge data loading, we rejected the bulk search file that has over 100 records and returned empty data.

According to the request of users, we increased the maximum records to 200 per page in bulk search results.

[MCIX-994] – Search by exact string only if from the external API

We allowed the search with only a full string match for external API users. This is to prevent people from getting a lot of data back by searching only substrings like only 6 digits. This is only applicable to only NEW APIs (Simple Search). We won't change the behavior of the old search API.

[MCIX-371] – Added a new feature to lock the user after 10 times failed attempts without any success

A new user locking feature is added to lock the user about 30 minutes after 10 times failed attempts without any success. if the user is locked, users need to wait 30 minutes to access back. We show the message with the remaining time under the login button.

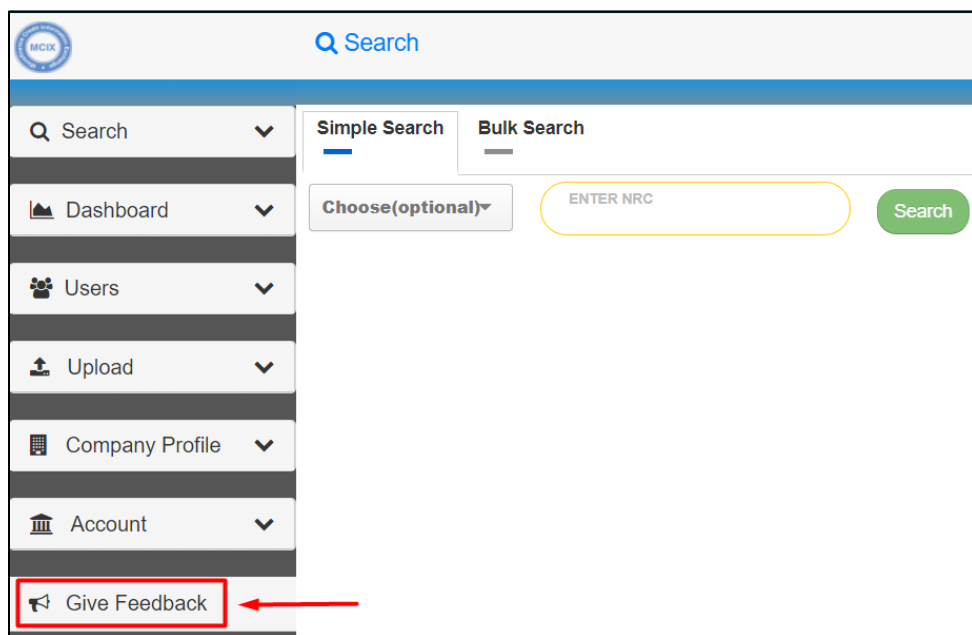

[MCIX-1237] – Audit Overview - can't see result for the previous months

We had a bug and we showed only current month data in the audit overview. Now, we fixed the bug to be able to see the 6 months (for now) data in the Audit Overview.
